| FEBRUARY 13, 2026 | Last day to file an application for a place on the ballot (5:00 pm). Last day to order an Election. |
| FEBRUARY 17, 2026 | 5:00 pm deadline for write-in candidates to file Declarations of Write-In Candidacy in a regular election. |
| FEBRUARY 20, 2026 | 5:00 pm deadline for a candidate to withdraw, by submission of a Certificate of Withdrawal or a notarized letter. First day that an election may be cancelled if all filing deadlines have passed and each candidate for an office listed on the ballot is unopposed. |
| FEBRUARY 23, 2026 | 10:00 am Drawing in Elections Office for ballot positions; Single- Member District 3 and At-Large Place 6. |

| APRIL 2 - APRIL 22, 2026 | Publication Period for Notice of Election. |
| APRIL 2, 2026 | Campaign Finance Report due for the period from the date a Campaign Treasurer was appointed through March 23, 2026. * |
| | Last day to register to vote for the May 2, 2026 Election. |
| | Last day for a voter to make a change of address that will be effective for the election. |
| APRIL 11, 2026 | Last day to post Notice of Election on bulletin board used for posting notices of meetings. |
| APRIL 20, 2026 | First day to vote early by personal appearance. |
| APRIL 24, 2026 | Campaign Finance Report due for the period of March 24, 2026- April 22, 2026, unless candidate filed for modified reporting or is unopposed. * |
| APRIL 28, 2026 | Last day to vote early by personal appearance. |
| MAY 2, 2026 | Election Day |
| | Last day to Receive Ballot by Mail (by 7:00 p.m. if envelope is NOT postmarked); May 4, 2026 - Last Day to Receive Ballot by Mail (by 5:00p.m. if envelope IS postmarked by 7:00pm) |
| MAY 5 - 13, 2026 | Period during which to conduct official local canvass of returns once the ballot board has finished counting late ballots. |
