JANUARY 8, 2024	Candidate packets available in Elections Office. Packets may also be requested online via RISD's Website. Elections Office: 400 S. Greenville Avenue, Richardson, TX 75081 Room 205
JANUARY 17, 2024	First Day to file for a place on the General Election ballot.
FEBRUARY 7, 2024	Candidate Training with current Board of Trustee Members. (6:00 pm, R.I.S.D. Administration Building- Board Room, 400 S. Greenville Avenue, Richardson, TX 75081)
FEBRUARY 16, 2024	Last day to file an application for a place on the ballot (5:00 pm). Last day to order an Election
FEBRUARY 20, 2024	5:00 pm deadline for write-in candidates to file Declarations of Write-In Candidacy in a regular election.
FEBRUARY 23, 2024	5:00 pm deadline for a candidate to withdraw, by submission of a Certificate of Withdrawal or a notarized letter. First day that an election may be cancelled if all filing deadlines have passed and each candidate for an office listed on the ballot is unopposed.

FEBRUARY 27, 2024	10:00 am Drawing in Elections Office for ballot position Single Member District 1, and At-Large Place 7
MARCH 15, 2024	Mandatory office hours begin- open 3 hours a day for election business through June 13, 2024.
APRIL 4-APRIL 24, 2024	Publication Period for Notice of Election.
APRIL 4, 2024	Campaign Finance Report due for the period from the date a Campaign Treasurer was appointed through March 25, 2024. *
	Last day to register to vote for the May 4, 2024 Election.
	Last day for a voter to make a change of address that will be effective for the election.
APRIL 13, 2024	Last day to post Notice of Election on bulletin board used for posting notices of meetings.
APRIL 22, 2024	First day to vote early by personal appearance.
APRIL 26, 2024	Campaign Finance Report due for the period of March 26, 2024- April 24, 2024, unless candidate filed for modified reporting or is unopposed. *
APRIL 30, 2024	Last day to vote early by personal appearance.
MAY 4, 2024	Election Day
	Last day to Receive Ballot by Mail (by 7:00 p.m. if envelope is NOT postmarked); May 6 2024- Last Day to Receive Ballot by Mail (by 5:00p.m. if envelope IS postmarked)
MAY 7- 15, 2024	Period during which to conduct official local canvass of returns once the ballot board has finished counting late ballots.
