JANUARY 6, 2025	Candidate packets available in Elections Office. Packets may also be requested online via RISD's Website. Elections Office: 400 S. Greenville Avenue, Richardson, TX 75081 Room 205
JANUARY 15, 2025	First Day to file for a place on the General Election ballot.
FEBRUARY 6, 2025	Candidate Training with current Board of Trustee Members. (6:00 pm, R.I.S.D. Administration Building - Board Room, 400 S. Greenville Avenue, Richardson, TX 75081)
FEBRUARY 14, 2025	Last day to file an application for a place on the ballot (5:00 pm). Last day to order an Election.
FEBRUARY 18, 2025	5:00 pm deadline for write-in candidates to file Declarations of Write-In Candidacy in a regular election.
FEBRUARY 21, 2025	5:00 pm deadline for a candidate to withdraw, by submission of a Certificate of Withdrawal or a notarized letter. First day that an election may be cancelled if all filing deadlines have passed and each candidate for an office listed on the ballot is unopposed.

FEBRUARY 24, 2025	10:00 am Drawing in Elections Office for ballot positions; Single Member District 2, Single Member District 4, and Single-Member District 5
MARCH 14, 2025	Mandatory office hours begin- open 3 hours a day for election business through June 12, 2025.
APRIL 3 - APRIL 23, 2025	Publication Period for Notice of Election.
APRIL 3, 2025	Campaign Finance Report due for the period from the date a Campaign Treasurer was appointed through March 24, 2025. *
	Last day to register to vote for the May 3, 2025 Election.
	Last day for a voter to make a change of address that will be effective for the election.
APRIL 12, 2025	Last day to post Notice of Election on bulletin board used for posting notices of meetings.
APRIL 22, 2025	First day to vote early by personal appearance.
APRIL 25, 2025	Campaign Finance Report due for the period of March 25, 2025- April 23, 2025, unless candidate filed for modified reporting or is unopposed. *
APRIL 29, 2025	Last day to vote early by personal appearance.
MAY 3, 2025	Election Day
	Last day to Receive Ballot by Mail (by 7:00 p.m. if envelope is NOT postmarked); May 5, 2025 - Last Day to Receive Ballot by Mail (by 5:00p.m. if envelope IS postmarked by 7:00pm)
MAY 6 - 14, 2025	Period during which to conduct official local canvass of returns once the ballot board has finished counting late ballots.
